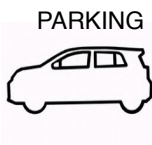

**An Information Sheet which includes the rules for vendors at this farm.**

1. ALL VENDORS MUST SETUP THEIR BOOTHS, SERVICE THEM AND TAKE THEM DOWN EITHER BEFORE 9AM OR AFTER 6PM DURING ALL WEEKEND DAYS. WHEN YOU DECIDE TO LEAVE FOR THIS SEASON, YOU MUST TAKE YOUR BOOTH DOWN EITHER BEFORE 9AM OR AFTER 6PM.
2. All vendors are expected to operate their booths from 10AM to 6PM during all of the days reserved. Vendors are responsible for the cleanliness of their area during and after the show. Vendors are expected to clean up around their booth spaces, all visible papers, etc., each evening at closing. Vendors are responsible for taking all of their belongings with them when their rent is used up.
3. You will be assigned a free parking space when you arrive.
4. Your paid invoice will be sent to you if you supply a self addressed, stamped envelope with your application fees. No refunds will be made after July 1, 2018. A 10% handling fee will be deducted from all refunds.
5. Consumption of alcoholic beverage(s) is not permitted at any time during business hours.
6. Smoking (including e-cigarettes) is not allowed in the yard and public places.
7. No generators are allowed without permission.
8. No pets are allowed outside your vehicle at any time.
9. Children must be accompanied by an adult and kept under supervision at all times.
10. Your booth must be fastened down well. If it becomes necessary for our employees to secure your booth to keep it from blowing away, you will need to pay a \$25.00 fee.

**You must leave the property no later than 2 hours after closing time, unless you have permission to stay longer.**
